She graduated from the Department of Political Science and Public Administration at the University of Athens and holds a PhD in International Relations from the University of Warwick (UK) where she studied as an A. Onassis Scholar. She has been a Visiting Research Fellow at the Hellenic Observatory (LSE, 2018), Visiting Professor at the European Studies Center, University of Pittsburgh (2016), Policy Scholar at the Woodrow Wilson International Center for Scholars (Southeast Europe Project), Washington D.C. (2010). She taught at the Department of Mediterranean Studies, University of the Aegean (Rhodes, 2007-2019) and worked as the Director of Studies and Research at the International Center for Black Sea Studies – ICBSS (Athens, 2005-2009) and in the Economic Affairs Committee of the Parliamentary Assembly of Black Sea Economic Cooperation (Istanbul, 2000-2004). She has authored *The Black Sea Region: Politics, Economy and International Relations* (in Greek, Athens: Kallipos Academic Publishing, 2025), *An Introduction to International Political Economy* (in Greek, Athens: Kallipos Academic Publishing, 2015), *Dynamics of Subregionalism in the Black Sea* (New York: Routledge, 2012) and numerous chapter contributions.
